### NOTICE INVITING TENDER

Sub: Tender Notice for "Disposal of dead stock i.e. e-waste.

SEEPZ SEZ Authority invites sealed quotations for disposal of e-waste (Access Control System Equipments) on "as is where is basis" from empanelled recyclers of e-waste agencies registered with SEEPZ SEZ Authority.

#### PROCEDURE FOR SUBMISSION OF TENDER:

1. Sealed Envelopes should be submitted in single cover superscribing "Disposal of damaged Access Control System Equipments (e-waste)". Name of the agency and contact person details should be mentioned on the envelope, failing which, the bid will be rejected.
2. The tender shall be submitted to Estate Manager (Estate Section), SEEPZ-SEZ Authority, Andheri (East), Mumbai, in person or through post/courier.
3. Non-adherence to the requisite compliance with regard to the conditions will result into rejection of the tender document and no appeal/request will be entertained.
4. Last date for submission of quotation is **21/09/2022** till **02:30** p.m. and the same will be opened at **04:00** p.m. on same day in the presence of bidders or their authorized representatives.
5. Interested bidders must be an empanelled agency registered with SEEPZ SEZ Authority, SEEPZ SEZ as Recyclers for disposal of E-Waste/lead acid batteries.
6. The bidder offering the highest rate shall be considered for award of contract.
7. Tender received late, unsealed and without superscription are liable to be rejected.
8. Incomplete, ambiguous and conditional tenders are liable to be summarily rejected.
