Sub: Empanelment of Agencies for disposal of e-waste/ lead acid batteries/ sludge through septic tank/ gutter waste containing non-toxic heavy metals

सभी इकाइयों और विक्रेताओं को सूचित किया जाता है कि जोन प्रशासन के सुचारू संचालन के लिए सक्षम प्राधिकारी ने निर्णय लिया है कि अब से ई-कचरा/लेड एसिड बैटरी/सेप्टिक टैंक/गटर अपशिष्ट जिसमें गैर विषैली भारी धातुएं हों, के निपटान के लिए जोनल विकास आयुक्त के अधिकार क्षेत्र के अंतर्गत SEEPZ SEZ प्राधिकरण में विक्रेता के पंजीकरण या पैनल की कोई आवश्यकता नहीं है। ऐसी वस्तुओं के निपटान के लिए यह पर्याप्त है कि विक्रेताओं के पास केंद्रीय/राज्य प्रदूषण नियंत्रण बोर्ड से वैध लाइसेंस और समय-समय पर लागू कोई अन्य लाइसेंस हो। वाणिज्य एवं उद्योग मंत्रालय के दिनांक 13.08.2010 के कार्यालय ज्ञापन संख्या 33015/3/10-जीए के अनुसार संबंधित एसईजेड के निर्दिष्ट अधिकारी द्वारा सभी विनियामक अनुपालन सुनिश्चित किए जाएंगे, जैसा कि दिनांक 13.08.2010 की अधिसूचना द्वारा संशोधित किया गया है। (प्रतिलिपि संलग्न)

All the units and vendor are hereby informed that for smooth operation of the Zone Administration, the competent authority has decided that henceforth, there is no need for registration or empanelment of vendor at SEEPZ SEZ Authority under the jurisdiction of Zonal Development Commissioner for disposal of e-waste /lead acid batteries/sludge through septic tank/gutter waste containing non-toxic heavy metals. For disposal of such items it is sufficient that vendors should have valid License from Central/State Pollution Control Board and any other License applicable from time to time. All regulatory compliance shall be ensured by the Specified Officer of respective SEZ in terms of Ministry of Commerce and Industry O.M NO.33015/3/10-GA dated 13.08.2010 as

amended vide notification dated 13.08.2010. (Copy enclosed)

## NOTIFICATION

New Delhi, the 13th August, 2010

S.O. 1996(E).—In exercise of the powers conferred by sections 6, 8 and 25 of the Environment (Protection) Act, 1986 (29 of 1986), the Central Government hereby makes the following rules further to amend the Hazardous Waste Management, Handling and Transboundary Movement Rules, 2008, namely :—

1. (1) These rules may be called the Hazardous Waste Management, Handling and Transboundary Movement Fourth Amendment Rules, 2010.
- (2) They shall come into force with effect from the 1st day of September, 2010.
2. In the Hazardous Waste (Management, Handling and Transboundary Movement) Rules, 2008 (hereinafter referred to as the said rules), in rule 8, in sub-rules (2), (3), (4), (5) and (6), for the words "Central Pollution Control Board", at all the places wherever they occur, the words "State Pollution Control Board or the Pollution Control Committee" shall respectively be substituted.
3. In rule 9, and rules, in Schedule VII,
  - (a) against serial number 2, under the heading corresponding duties, item vi and the entry relating thereto shall be omitted;
  - (b) against serial number 3, under the heading corresponding duties, after item vii, the following shall be inserted, namely :—

"viii. Registration and renewal of registration of Recyclers or Re-processors"
4. In the said rules, in rule 14, appended to the said rules, under the heading, for the words "Central Pollution Control Board", the words "State Pollution Control Board or the Pollution Control Committee" shall be substituted.

Dear Sir,

I am writing to you regarding the issue of safe disposal of electronic waste. Electronic waste is one of the fastest growing waste streams in the country.

2. The Ministry of Environment and Forests has notified the Hazardous Wastes (Management, Handling and Transboundary Movement) Rules, 2008 for proper management and handling of hazardous wastes, including e-waste. It is essential that e-waste generated in various offices is disposed of in an environmentally sound manner in accordance with these Rules. As per these Rules, the occupier has the responsibility for safe and environmentally sound handling of such wastes generated in their establishments.

3. Further, the units handling and engaged in activity like collection, segregation, dismantling and recycling of e-waste are required to register with Central Pollution Control Board (CPCB). At present, there are 16 dismantlers/recyclers registered with CPCB. A list of registered recyclers is enclosed and is also available on the Website of CPCB. (<http://www.cpcb.nic.in/divisionsofheadoffice/nwmd/e-Waste.pdf>).

4. I would, therefore, request you to kindly instruct all establishments under your Ministry to auction/sell the e-waste generated in their office complexes to registered recyclers only.
