Further, Specified Officer stated that, the above figures are based on the details furnished by the SEZ unit and data available on SEZ Online and as per the letter (e-mail) submitted in this Office on 20.11.2023, 16.01.2025 and on 21.02.2025. Findings

1.	This is 4 th and 5 th year i.e. 2022-23 to 2023-24 of 1 st block period (FY 2019-20 to 2023-24).
2.	The unit has achieved export revenue of Rs. 2291.09/- Crore as against projected export of Rs. 3380.00/- Crore i.e. 67.78% during the period for FY 2022-23.
3.	The unit has achieved export revenue of Rs. 3967.90/- Crore as against projected export of Rs. 3560.00/- Crore i.e. 111.46 % during the period for FY 2023-24.
4.	Cumulative Net Foreign Exchange Rs. 3759.26/- Crore is positive for FY 2022-23 as per APR.
