2. Shri Binod Singh, SDF -II working committee

- In open ground near SDF – II, the large number of debris is lying of the construction works of NEST-II building. M/s. CK Infra has the dumped the debris in the open ground. Committee has requested to remove the debris on urgent basis.
- The leftover material causes the waterlogging in the building premises.
- The letter in this regard is sent to DC office from the SDF-II committee on 21<sup>st</sup> May 2025.
- The water bills for TOWER – II are erroneously raised by the MIDC. The excess amount of Rs. 40 Lakhs is claimed by the MIDC. The committee has written a letter to MIDC. The reply received from MIDC wherein it was mentioned that the water supply will be cut down if the water bills are not paid in next 7 days.

Shri Hanish Rathi, ADC informed unit that the notice was already issued to the contractor M/s. CK Infra regarding the same and if the contractor fails to remove the debris, then the DC office will remove the debris in next 4-5 days.

Shri Hanish Rathi, ADC asked the committee member to share the copy of letter written to MIDC & will take up the issue with MIDC Deputy engineer. Also, asked them to follow-up with the MIDC for the same as the issue under the purview of MIDC.
